- Bud Adams came forward and said there should be equal place for Century Link and Zito Media because companies do not want to share conduit.
- Judith Case came forward and spoke to the Council about an incident in August where she was attacked by four dogs. She said she would like to address the animal ordinance concerning vaccination of animals. She said she does not believe protocol was followed and she thinks the dog should have been quarantined at the animal shelter. Judith said she thinks the City Code should be revisited concerning this issue.

FINAL COMMENTS

Councilman Brennan said he wanted to revisit updating the animal ordinances. He said he would like to work with the Police Department and Council Minutes - September 26, 2023

Animal Shelter regarding the ordinance in question. He read subsection B of the animal code concerning animal bites. He would like to have it clarified in 6-6-7B if the animal is vaccinated quarantining at home is fine, but if not vaccinated they should be quarantined at the shelter.

Mayor Sykes said he would like to address the political signs on city property.

Geoff Schroder, City Attorney said an argument could be made that signs on a vehicle are different than signs staked on city property. That signs on a vehicle are no different than a bumper sticker supporting a political candidate whether local or national.

Mayor Sykes said this morning he met with the Singapore Ambassador.
