The Council of the City of Mountain Home, Elmore County, Idaho, met at the Mountain Home City Hall Chambers, 160 South $3^{\rm rd}$ East, Mountain Home, Idaho on October $24^{\rm th}$, 2023. A quorum was established with Councilwoman Garvey, Councilman Brennan, Councilman Green, Councilman Bundy and Mayor Sykes being present.

Councilman Bundy Statement:

Councilman Bundy gave a statement regarding the Special City Council on October 2, 2023. He said he was unable to be present for that meeting and read the motion from that meeting where the fees for the 42% increase on golf fees.

Statement about the bills:

Paula Szafranski, City Treasurer gave a statement correcting the bills, she said it was the vac truck that was repaired not the boring rig.

Councilman Green Statement:

Councilman Green said he felt like there was a lot of misinformation going around with regards to who made motions during Special City Council Meetings.

PUBLIC HEARING

1. Public Hearing on proposed Golf Course fees.

The public hearing was opened at 5:06 p.m.

Decker Sanders came forward to speak against the approval of the proposed golf course fees.

Lyn Bratton addressed the Council speaking against the proposed increase in golf course fees.

John Andrews spoke against the increase in golf course fees that had been suggested.

Brendan McCarthy came before the council and said he felt the golf course is an amenity and spoke of the base golf course being nearby. He was not in support of the 42% increase.

Carlotta McCarthy came forward against the proposed golf course increases and the elimination of the High School Golf Team pass.

Chrissie Neuer spoke against the proposed increase in golf course fees.

Debbie Meredith came before the council to speak against the proposed increase for the golf course storage and the user fees that are charged.

Mark Russell spoke to the council about the public notice that was published, he did not feel it had been noticed properly for a decision tonight.

Helen Stolz spoke to the council against the increase in fees that had been proposed.

David Tapp spoke to the council about various issues he has with the running of the golf course and against the proposed rate increase that had been advertised.

Brenda Schwarze came forward and addressed the council stating the Council Minutes - October 24, 2023

proposed fees are unaffordable for retirees, widows and widowers, she specifically took issue with the cart storage fee increase.

Roslyn Cundick addressed the council against the proposed increase in golf fees.

Don Guss came forward with suggestions for running the golf course.

Jeff Wilson came forward and agreed the proposed fees for the golf course were too high.

Ed Schmelzer spoke to the Council against the suggested increase in golf fees.

Ernest Bedont spoke against the proposed increase to the golf fees and suggested there be different rates for residents versus nonresidents.

The Council also received emails or letters from Terri Manduca, John Lefler, Richard McMahon, Gisela Light and Robert Livesay. There was also an email forwarded to the Council from Jeff Rhodes from a citizen Dusty, no last name given.

The public hearing closed at 5:45 p.m.

Mayor Sykes and Councilman Green left the meeting and the meeting continued.

President of the Council, Councilwoman Garvey granted a recess.

Following the five-minute recess, the Council came back in session.

Councilman Brennan asked T.J. if he could explain the reason the Council had requested T.J's presence for the meeting tonight.

T.J. said for the rate discussion, because of the importance of the topic.

Councilman Brennan asked if at the time the rates were first proposed was he in favor of them.

T.J. said he was not and felt the increases should be tapered.

Councilman Brennan said at the time it was clear to the Council present Council Minutes - October 24, 2023

T.J. was in full support of the rate increases. He said now with everyone here listening T.J. is blaming it on the Council.

T.J. said he does not remember being in support of a 42% increase. He said he had supported a capital improvement plan with the rate increase. He believes golfers respond to something they can tangibly see.

Councilman Brennan said they were trying to work through that with T.J.

T.J. said he was referring to a plan for the property.

Councilman Brennan made a motion to table tonight's action item for increased rates. He felt it needed to go side by side with the contract discussion. Councilman Bundy seconded the motion.
