Update HUB: ERN signed at Special Meeting. Commissioner Valley has not received a quote or cost from Idaho Power. Commissioner Bermensolo advised that it may be best to our own engineer look at the project and fill out the questionnaire for Idaho Power which will include all pertinent information. Everything is at a standstill until this is done. A check for \$15,000 was received from Wietz and Company which is required for the ERN.

Update Mountain Home Adult Academy: Their contractor hopes to start construction in January, possibly sooner. The reuse appraisal should be back by January.

Discuss-Possible New URA District: Laws have changed to be able to create a new district. It will need to be put on the ballot in May. Concern is that not enough voters have knowledge of the URA and will need to be educated ahead of time. Brock will do more research into this. Mayor Sykes recommends to pause until there is more information. Commissioner Bermensolo recommended that we remove this from the agenda for now.

Update on Railroad Park Pavilion and Sidewalk: The sidewalks in Railroad Park are done. String lights will still be put up when silicone clips arrive. Planning a his/her bench inside pavilion.

Discussion/Decision-Railroad Park Skating Rink and Splash Pad. ACTION ITEM: Mayor and Tiffany presented a downtown gathering venue in Railroad Park to include a splash pad and skating rink. This could also include a small event center with bathrooms and concessions. The URA likes the idea and feels it is something that could be done. Mayor Sykes will do more research into pricing and bring it back to the board. Commissioner Jett makes a motion to table this discussion until more information is available. Commissioner Wright seconded. All vote AYE.

Business from floor: The Mayor appreciates everything done by the URA.

Adjourn. Commissioner Wright motions to adjourn.
