- Darcy Braithwaite, Recreation Superintendent said they are in the third week of soccer and the walking path bridge will be under construction soon. She said they are preparing for Spooktacular next month.
- \bullet Gene Palmer, Street Superintendent said they are prepared to pave in front of Hacker tomorrow morning.
- Lieutenant Russel Griggs thanked all the COPS and officers that worked through AFAD and the Homecoming Parade. He said they are working at Hacker with a program called Adopt a Cop.
- Hank Patrick, Building Official said Code Enforcement is doing a great job and the full time enforcement officer is working on his certifications.
- \bullet Mark Moore, Fire Chief said they are testing the fire trucks and doing preventative maintenance. He said the open house is October $15^{\rm th}.$
- \bullet Brock Cherry, Community Development Director said Chris Curtis and John Matthews have both become certified to fly drones for the city. He said the new city podcast is going great.

• Rich Urquidi, Director of Public Works said the temperature changes have curtailed people's water use and farming has about wrapped up. The lagoon levels are where they need to be for winter collection.

Councilman Brennan asked how things were looking with the new well and sand trap.

Rich said there was quite a bit of sand at 1,500 gallons a minute, so they are looking at ways to get rid of the sand in the water. The expense of remedying the sand would cost as much as drilling a whole other well, so one option they may utilize is slowing the flow down and putting in another hole.

- Tiffany Belt, City Clerk said she has been working with the contractor for the pool and work should be started soon and they will be working over the winter to complete it.
- Councilman Brennan said he was concerned about the amount of law enforcement calls over the Farmer's Market in Railroad Park.

Mayor Sykes said moving forward the park belongs to the person with the reservation.

Councilman Brennan said he would like to see the lease on Railroad Park split into three sections.

• Mayor Sykes said City staff will be doing acts of kindness this week for Tiger Kind. He said he signed the final paperwork today for the DOD Grant and the money should be coming to the City from the grant soon.

He has spoken with several people who believe this is not the right thing to do, and he doesn't disagree. He said he supports a shelter of this nature and even a shelter for men for the same purpose.

Councilman Brennan made a motion to deny payment to the Domestic Violence Council.

Councilman McCain asked to hear from the City Attorney.

Paul Fitzer, City Attorney said it could be construed you are discriminating against a protected class.

Councilman Brennan asked if it changes anything because it is a specific cause and it is a donation from the City.

Paul said the city is not in charge of the organization and cannot impose regulations on the organization.

Councilwoman Garvey said she understands the concern, but this group does good work, and to take money from them could really hurt the work they do.

There was no second to the motion and it died.

Councilman Brennan made a motion to table this item until the Director of the Elmore County Domestic Violence Council could come before the Council and speak to how some victims of domestic violence are housed.

There was no second and the motion died.

Councilman Brennan made a motion to table this item indefinitely.

Councilman Stokes said he understands the concerns, but he feels sure there is some sort of protocol in place to deal with sheltering abuse victims that may identify as female.
