OLD BUSINESS

1) Action Item: Deliberation/Decision on Mellen Water District land lease.

Erica Pedroza was present and said Hiddleston Drilling recommends getting rid of the pump completely, but Treasure Valley Drilling said the springs of the pump need to be cleaned up and they can do that.

It was decided Mellen Water District would no longer attend every meeting but would be present if there were updates to convey to the Council.

NEW BUSINESS

1) Items removed from the Consent Agenda

There were no Items removed from the Consent Agenda.

2) Discussion Item: Deliberation on Mountain Home City Code 7-1A-9 Water Rights Fee.

Councilman Brennan said in the City Code there is a price per acre for water rights but there was not any prices listed for land size under one acre. He said when you divide the current acre down it is 4.8 cents per square foot. And he recommends a five cent per square foot fee. Moving this fee into Title 9 seemed like the most appropriate place for this fee.

Rich Urquidi, Director of Public Works said he thought there might be an easier way to divide the annexation fee but he would work with Keller Associates to determine the best way to move forward with this.

It was decided to have a draft of this ordinance change at the first City Council meeting in December, so Rich had time to consult with Keller on a fee schedule for this request.

3) Discussion Item: Lynn Carrillo of Ethridge Legacy Homes regarding a proposed Hydrologic Study (H&H)

Lynn Carrillo with Etheridge Legacy Homes was present and requested the City pay for Hydrologic Study required for this property since it is in a flood plain and the development would refund the city once the development process was further along. She said it would be refunded to the city upon entitlement.

Councilman Brennan said he was not interested in the city paying for the study.

It was the consensus of the Council it was not appropriate use of funds to pay for the study.

Paul Fitzer, City Attorney said they were not permitted to pay for that study anyway.

4) Deliberation/Decision on proposed Personnel Policy updates.

The Council discussed proposed changes to the personnel policy.

It was decided this item would be tabled until the next meeting when the proposed changes could be evaluated and possibly implemented into the Personnel Policy.

Councilman Brennan said his reason for advocating a blood test is a blood test is far more specific than a simple urine test.

- Bud Adams spoke to the Council concerning the conduit issue with fiber.
- \bullet Mark Bryant stood before the Council and said on February 13th, 2023 there was a discussion on how the ARPA funds would be used. He said he felt safe drinking water was a priority.
- ullet Ellie Meyers, a resident at Sunset Manor said the manager at the apartments has scared the tenants living there and the situation is getting worse for the tenants.
