A quorum was established with, Councilwoman Garvey, Councilman Green, Councilman McCain, Councilman Brennan and Mayor Sykes being present.

DEPARTMENT HEAD COMMENTS/REPORTS

- Shasta Hochstrasser, Library Director said this week is National Library Week and they have a lot of programming planned throughout the week to celebrate. Saturday will be the Teen After Hours Activity.
- ullet Jake Olsen, Golf Course Superintendent said he has been working on the greens and with the weather the Golf Course is slowly coming around.
- Betsy Hiddleston, Communications Specialist said the City recently did a proclamation for the Elmore County Domestic Violence Council to support Denim Day. Food distribution will be this week on Wednesday. She said the URA website went live last week.
- Darcy Braithwaite, Recreation Superintendent said Arbor Day is this week and Fourth Grade Field Day is this Friday. She let the Council know this would be her last City Council meeting and she accepted a position as the District Clerk of the Glenns Ferry School District.
- Miguel Pedroza, Parks Superintendent said they are mowing now and getting things ready for spring. He said they have hired a new Cemetery Sexton.
- \bullet Dave Sonnentag, Water Superintendent said they are starting the water line for out at the Airport next week.
- \bullet Gene Palmer, Street Superintendent said they have the sander equipment all taken off now and are moving into potholing.
- ullet Don Flynn, Wastewater Superintendent said on the 2^{nd} of May they will be starting Runway Estates and getting the inspections done for that. He said there is over 290 million gallons of wastewater so the farm should be able to run all summer off of that.

- Rich Urquidi, Director of Public Works said they have the results from the last pump test so a change order will be coming in. A lot of the good water was down at the lower strata so they will drill back through that and try to go as low as possible.
- Tiffany Belt, City Clerk gave the Council the insert Councilman Brennan said he would like to have in the water bill for May. She said the Farmers Market is starting up for the year in May. She said she has been accepted to the AIC Leadership Conference, so that will be a two-day training.
- Paula Szafranski, City Treasurer said City Staff sat through a demo this morning for a new credit card carrier, it would give customers the option of paying on an app.
- Councilman Brennan said Commissioner Corbus gave a shout out to the City for our cooperation a couple years ago in boring under Mashburn Rd. for the water recharge. He said the flyer in the water bill has a QR code for a survey the County Commissioners are conducting.

Rich Urquidi, Public Works Director said at this time it is just the front parcel of property being annexed.

Councilman Brennan said there was some language in the reports for this that didn't make sense.

Brock read the passage of the report and said at the time of the hearing with Planning and Zoning, someone expressed the applicant did not wish to be annexed but that was incorrect, the applicant was interested in annexation.

Councilman Brennan asked if only the front lot was being annexed, would it be the only one receiving city services.

Brock said that was correct, the lot that was not annexed is not eligible for any city services.

Councilwoman Garvey made a motion to approve the Planning and Zoning Commission recommendation and finding of facts with conditions for annexation and zone C-4 Heavy Commercial located at Airbase Rd. Councilman Brennan seconded the motion.

3)Action Item: Deliberation/Decision on Planning and Zoning commission recommendation and finding of facts with conditions for a conditional use permit to allow an RV Park. (Staff report provided via email on April 12, 2023)

Hunter Christiansen was present to discuss the proposed RV Park development.

The Council discussed the proposed development with Hunter.

Hunter said currently they are planning for 175 stalls, with many amenities for residents and guests.

Councilwoman Garvey asked about the traffic flow.

Brock Cherry, Community Development Director said the comments from ITD were no material improvement will be needed based on this development. He said money from Impact Fees could be used to provide for a traffic light in that location at a later date if it is so needed and the city has it in their Capital Improvement Plan.

Councilman Brennan said he doesn't feel he has had enough time to analyze all of this. He said he isn't sure if it would be best to collect street impact fees or if we should identify commercial projects and collect from a late comers agreement.

Brock said since we have so much commercial construction in that area at the moment we could identify the light as a project the city would like to use the money for.

Paul Fitzer, City Attorney said the answer is no, you cannot waive a portion of the impact fees. The impact fees go into a giant pool and then are calculated into the CIP as a whole, so different applications cannot opt in or out.

Councilwoman Garvey said we can put this in our CIP but we cannot pinpoint an exact time because we cannot spend impact fee money before we have it.

Brock said since building permits have been submitted he feels comfortable the permits will be picked up.

Councilman Green made a motion to approve the Planning and Zoning recommendation and finding of facts with conditions for a conditional use permit to allow an RV Park. Councilman McCain seconded the motion.

The majority of the vote being in favor, the motion was carried and so ordered.

Councilman Brennan said he didn't feel like he got enough time to digest all of the information on development and he wants to get the decision right, so he was abstaining from the vote tonight.

4) Action Item: Deliberation/Decision on a Public Institution and Education Solution proposal for a Gaming Study and Infrastructure cost model by CBRE.

Brock Cherry, Community Development Director said the City has begun to reach out to industry experts that have knowledge the City does not on this type of project. Ultimately, the decision on the casino rests with the governor but it is likely the feelings of the City will be taken into account.

Zach Simons with CBRE came forward and spoke to the Council about the company and the experience the company has with gaming. He said as a member Council Minutes - April 24, 2023

of the community he wants to have the pros and cons of the entire proposed project.

Councilwoman Garvey said she personally feels the gaming study is putting the cart before the horse, because it is still at the Bureau of Indian Affairs at the D.C. level. Then once it gets through that the Paiute Tribe and Bannock Tribe will need to sort out their claims. The governor also seems to have some apprehension because of the precedence that would be set with the decision. She said she felt it was a good partnership to start but for \$77,000.00 we are getting ahead of the game. She said some of things being proposed to study are beneficial to the tribe and not the City, such as the labor force study. If they want to come to the table with providing this information, then she thinks they should be a partner in paying for the study. Right now, she doesn't see that we need the study yet.

Councilman McCain said he agreed with Councilwoman Garvey.

Councilman Brennan said he agrees this is a big decision and has a chance to change the course of the City. It will have a big impact on Mountain Home.

Zach said the biggest thing is CBRE is presenting a proactive instead of reactive approach to this life changing community decision.

The Council discussed what they would like to see from the study when it came time to deploy it.

Councilwoman Garvey made a motion that we table deliberation/decision on a Public Institution and Education Solution proposal for a Gaming Study and Infrastructure cost model by CBRE.

Councilman Brennan asked if this was tabled indefinitely.

Councilwoman Garvey said she would like to see more information from the state as well.

Brock said he felt Councilwoman Garvey was correct, the casino has the information and maybe one of the city's requests is to get that information.

Councilman Green seconded the motion.

Councilman Brennan said he would like to see what everyone's thoughts are on setting up vendor use in the park and what it would look like.

Tiffany Belt, City Clerk said according to current city ordinances there would need to be a Special Event Permit because Legacy is in a residential area. Also, Legacy Park is not in a designated area for Mobile Food Concessions.

Councilwoman Garvey said her concern is the garbage, and she would like Council Minutes - April 24, 2023

more information on the costs associated with increased garbage.

Councilman Brennan said the vendor would be responsible for managing their trash. He said people would be carrying food and napkins all across the park and people do litter, but he didn't want to see a good idea not utilized because some people are irresponsible.

Tiffany said it is at the city's discretion to have dual reservations for the parks with Special Event Permits.

Councilman Brennan said he would like to move forward with a work session.

The Council decided to set a work session for either the 8^{th} or 23^{rd} of May.
