Item J: Pass Resolution #08-20 - Approving Lease Agreement with David B. Lewis dba Mountain Home Speedway, LLC to lease the Motocross Track and Mud Bog Pit at Optimist Park for Motocross Racing and Mud Bog Events and Authorizing the Mayor and City Clerk to sign. ACTION ITEM.

Councilman Brennan said he was happy to see Dave and his group would be taking care of all the ground maintenance for the motocross track and mud bog pit but he wasn't happy the City would be paying for water for the events and he wanted the fee to be more than the \$5.00 listed.

Dave Lewis was present and said if he is taking over all of the work out there he doesn't see he should be paying for the water out there. He said it doesn't sit well with him when he has offered to take over the Motocross track and Mud Bogs because he knows the City doesn't have the man power or the time to run all of that.

Councilman Brennan said he would guess every business owner in town would say they provide a service to the City. Although most of those business owners also pay property tax. He said when they have an event they don't allow anything else, such as private parties to be held. So Dave's lease would be for five dollars a year and he would hold the power to decide who can or cannot book a private party that would pay the City \$45.00 a day to be there.

Dave said yes, he would have it at his discretion, however he would be the one putting all the work into the City's ground for the Motocross and Mud Bogs area at Optimist Park.

Councilman Brennan made a motion to deny resolution #08-20 - Approving Lease Agreement with David B. Lewis dba Mountain Home Speedway, LLC to lease the Motocross Track and Mud Bog Pit at Optimist Park for Motocross Racing and Mud Bog Events and Authorizing the Mayor and City Clerk to sign.

There was no second to this motion and the motion failed.

Councilman Bundy said he thought it would be beneficial to set up a Special Meeting where the City Council could work this out with Dave Lewis dba Mountain Home Speedway, LLC.

Councilman Stokes said he also takes issue with raising the water rates for every household in Mountain Home but giving it away for the Mud Bog events.

It was decided the City Clerk would set a Special City Council Meeting about the lease of the Motocross track and Mud Bogs with Dave Lewis dba Mountain Home Speedway, LLC.

<u>Discussion/Decision on Fresh Friday Farmers Market New Vendor Fee and set public hearing. ACTION ITEM.</u>

Paula Szafranski, City Treasurer presented to the Council Fresh Friday, a proposed program for Fresh Friday a Farmer's Market Program with an EBT machine.

Councilman Brennan said he doesn't think it is in the City's purview to host this kind of event.

Paula said ideally, they would have a Farmer's Market Manager, but Council Minutes - March $9^{\rm th}$, 2020

until it was running smoothly, and the City knew how everything ran, City employees would be there running it. A private person could not be responsible for the EBT machine it had to go through the City.

There was a discussion about the requirements of having a City EBT machine for a Farmer's Market.

Councilman Bundy said he agreed that the City shouldn't be running this but it didn't sound like this was something that would get off the ground without the City's involvement at least for the first year. He said he was okay with the City being involved with this for the first year with the understanding they would be giving it over to someone else to run after the first season.

Mayor Sykes said they have had citizens ask about getting fresh produce from local vendors and wanting the EBT machine service.

Councilman Bundy made a motion to approve the Fresh Friday Farmers Market new vendor fee at \$25.00 and set a public hearing date of April $13^{\rm th}$, 2020 at the regularly scheduled City Council Meeting at which time they would decide if they wanted to proceed with this or not. Councilman Stokes seconded the motion.

Councilman McCain said it looked like this would be done in four sections and he wanted to know if the City wanted to have four cuts made to the street.

Gene Palmer, Street Superintendent said they always like to keep the cuts in the road to a minimum.

City Clerk, Nina Patterson said she wanted to clarify since Hank is not present that Mr. Gillespie wants to build two fourplexes at a time, for a total of four fourplexes. If that were the case it would only be two cuts to the road.

Councilman McCain said he doesn't think a certificate of occupancy should be issued for any of the fourplexes until he has put all of the curb gutter and sidewalk in for the area. The Council discussed how much of the street Kent Gillespie would be responsible for paving.

Councilman McCain made a motion to approve the amendment to the annexation agreement for Kent Gillespie stating he will put in curb, gutter and sidewalk on the side he is putting the fourplex in on and pave the road complete to the intersection. Councilman Stokes seconded the motion.

Rich Urquidi, Public Works Director said the second phase of the Downtown Plan is starting and this has been talked about, to stop threw traffic on South $2^{\rm nd}$ East and East Jackson which is the easiest and most cost effective way to handle traffic issues in this area. He said he expects it to help keep traffic from backing up because the other sides of the intersection won't have to wait as long for the light to cycle.

It was decided to send this item to the Traffic Safety Committee for review and have their recommendation.

Cody Black, owner of Meadows Trailer Park was present via telephone to discuss the annexation of the park.

The Council discussed the possible annexation of Meadows Trailer Park and what the City would require for the park to be annexed. They talked about what water rights the park owns and if the City would be interested in those as part of an annexation agreement.

Mayor Sykes said Mountain Home is one of the 10 safest Cities in Idaho and if Meadows were to be annexed with the level of calls they get out there it would take Mountain Home out of the top ten. He asked if Cody had a way to combat that.

Cody said he is looking at getting rid of some problem tenants and installing cameras. He said he wants the park to be more family friendly and has looked at installing a playground.

Councilman Brennan made a motion to deny the annexation of Meadows Trailer Park. Councilman McCain seconded the motion.

Discussion/Decision on county boring project. ACTION ITEM.

Mayor Sykes said Elmore County has gotten all the permits to allow boring from one side of a gravel pit to the other side of frontage road by the Highway District building over to BLM ground. It will help to recharge the aquafer. He said he feels the City also has part in this because they will use the water too. Mayor Sykes asked City Treasurer, Paula Szafranski to come up with how much it would cost to have the City employees bore that. The estimated cost was about \$17,000.00, and the City may want to look at an

in-kind exchange for this boring work, since the County has already invested a lot to this project.

Councilman McCain said Commissioner Corbus has said the County pulled all the permits and since the City will also be using the water gained from this they are looking for some help from the City to get this project done.

The Council discussed the idea of providing the boring work for the project at no cost to the County and splitting the cost of the pipe required.

Mayor Sykes said he's asking the Council if they would like to go ahead and work with Elmore County on this project and if so would they agree to provide the work as in-kind, and would the City work with the Commissioners to see what they need to get the project done.

Councilman Brennan said this water is everyone's water and the County has put everything in so far so he has no problem splitting the cost of this portion of the project with the County.

Councilman Bundy made a motion to provide the boring machine, any fuel or supplies needed and employee time as in kind work for the Elmore County boring project and the City will purchase the 8 inch boring drill bit required and help the County pay for the pipe in a not to exceed amount of \$10,000.00 to be paid from the Future Water Project line in the water budget, the County will obtain the required permits and pay all the permitting fees. Councilman McCain Seconded the motion.
