Discussion/Decision on Meadows Trailer Park Fees

Mayor Sykes said Cody Black and a partner recently bought the Meadows Trailer Park and they would like to pay for each trailer as they are hooked up to City services instead of paying for every unit at once.

Councilman Schipani asked if they would need a Conditional Use Permit once they are annexed in.

Mike McCain, Building Official said they would be annexed in as they are unless they already have a Conditional Use Permit through Elmore County.

Mayor Sykes asked if they would have to put in curb, gutter and sidewalk once they were annexed in.

Mike said if they kept it a private lane they would not but if they wanted access to street services they would have to add curb, gutter and sidewalk in.

The Council advised they are fine with the park paying as they put units in, instead of paying for all of the units at once.

Discussion on Proposed Economic Development Ordinance

There was a discussion about the proposed Economic Development Ordinance. It was decided to continue this discussion to the next City Council Minutes - January 8th, 2018

<u>Discussion on Updates to the City Personnel Policy in regard to Dress</u> Code, Tattoos and Body Piercings

Councilman Brennan said he does not like how the policy states if a department has additional regulations those will also apply. He feels if there was a more restrictive policy for a department they should just follow the more restrictive policy. He feels having two different policies makes it hard to enforce.

Nina Patterson, City Clerk said to clarify if there was a more restrictive policy than the City wide policy for a department then they would only follow the more restrictive policy.

Councilman Bryant asked if it could be changed to in addition to.

Councilman Brennan said that is saying the same thing as also.

Mayor Sykes said it was the Police Department that had the additional policy on tattoos and asked if there were any other policies the department had in addition to the policies the City uses.

Nina said she had spoken with Mayor Sykes when Councilman Brennan's concern was first brought up and they had wanted both policies to be in place because there may be something covered in one policy that is not covered in the other.

Councilman Brennan asked if there was an instance where one policy contradicted the other.

It was decided Nina Patterson, City Clerk would work with the Mayor and Department Heads to get the correct wording on the policy and the policy would then be brought back to the Council for approval.

<u>Discussion on Adopting a Nicotine Free City Employee Policy for the City of Mountain Home Employees</u>

Mayor Sykes asked Nina to clarify what this policy is.

City Clerk, Nina Patterson said it is a Nicotine Free City Policy for Employees of the City of Mountain Home while they are at work, not a policy for the entire City as a whole.

Councilman Brennan said he thinks this policy needs work because as soon as this policy becomes effective the employees will be held to it and to cut an employee off from nicotine cold turkey during an eight hour shift will be hard for them to comply with. There is no provision to give employees time to quit.

Mayor Sykes said they will be allowed to smoke on their fifteen minute break as long as they are not on City property.

Councilman Bundy asked if someone is seeking a healthier lifestyle and they are on nicotine patches would that be ok.

Mayor Sykes said it would.

Director of Public Works, Rich Urquidi asked if an employee would have to walk two blocks away on a fifteen minute break to smoke.

Mayor Sykes said it is currently written they cannot walk to an adjacent area but it could be changed.

It was decided City Clerk, Nina Patterson and Mayor Sykes would work with Department Heads and employees to make changes to the proposed policy Council Minutes - January $8^{\rm th}$, 2018

that would ensure it is of the most benefit possible to both the City and its employees before bringing it back to the Council for approval.
