OLD BUSINESS

Discussion/Decision to approve and authorize the Mayor and City Clerk to sign the Agreement for the exchange of City-owned real property for real property owned by Rimco, Inc. as described in the Notice of Public Hearing that was published in the Mountain Home News, and to authorize and direct the Mayor and City Clerk to proceed with the closing of the exchange and to sign all necessary documents required to do so

Councilman Bundy said he wanted to reiterate this process has been done in the open and has been public. He said he is grateful Rimco wants to grow in the community of Mountain Home.

Councilman Bryant said having fifty new jobs in Mountain Home is huge for the City.

Councilman Brennan said Rimco is a great business that he respects. However, he felt the deal was not in the best interest of the City because of the difference in assessed property value between the two parcels of property. The difference in land value of the two areas of land is over \$900,000.00, and the City has also offered to move a water main that is running through the property where Rimco, Inc. wants to build at the City's expense. He proposed the City trade the land on South Main for the two vacant lots on Industrial Way where Chuck Ceccarelli would like to build his new building. Giving away the ground where Idaho Wrecker Sales and In the Ditch Towing are currently located is not in the best interest of the City.

Councilman Schipani said Chuck creates jobs in the community and his company has helped with grant writing to bring vocational classes to the high school when the City has needed it, so he has no problem with the land swap. Also regardless of who purchased the property it would be at the City's expense to move the water main pipe, as it was mistakenly put there in the first place.

Mayor Sykes asked Councilman Brennan what the value of drainage to College Park Subdivision, $3^{\rm rd}$ street and $10^{\rm th}$ Street are. Having the land behind Public Works could keep homes from flooding.

Councilman Brennan said he sees the value in that and the residents should be protected. Though with the changes in the deal he is proposing the people would still be protected.

Councilman Bryant said just because the assessed value of the property was high doesn't mean it can be sold for that. He said this property may Council Minutes - January 22^{nd} , 2018

not have any other interest in it for another twenty years.

Chuck Ceccarelli, the owner of Rimco said he didn't think there was another way to make the deal work. He said he was invited to sit on a small business council and when asked about issues he faces for his business he said the number one issue is the low property values make it hard to build in Mountain Home. He believes if he builds a six million dollar building it will be worth four million dollars.

Mayor Sykes said anytime the City has needed something from Rimco, they have always been more than willing to help.

Councilman Bundy made a motion to approve and authorize the Mayor and City Clerk to sign the Agreement for the exchange of City-owned real property for real property owned by Rimco, Inc. as described in the Notice of Public Hearing that was published in the Mountain Home News, and to authorize and direct the Mayor and City Clerk to proceed with the closing of the exchange and to sign all necessary documents required to do so. Councilman Schipani seconded the motion.

Councilman Brennan asked Chuck Ceccarelli if there was any way he could make the deal work without the City giving up all of their land.

Chuck said he honestly doesn't know.

FINAL COMMENTS

- ullet Shirley Batchelor, Wastewater Superintendent said lagoon volumes are fifteen million gallons less than last year, so it has been a much easier year.
- ullet Miguel Pedroza, Parks Superintendent said February 12th is the delivery date for the materials to build a new canopy at Carl Miller Park. He said some of the bushes at Carl Miller aren't in the best shape so they are taking them out.
- \bullet Dave Sonnentag, Water Superintendent said he is working with the engineer on the new tank.
- Tiffany Belt, Recreation Superintendent thanked the Council for passing the agreement on the new Recreation Software. She said it is enabling her to push her department forward and save some money as well.
- William Lamb, Library Director said they are finishing a three year strategic plan and it will go to the board next Thursday and once it is finalized he will send it to the Mayor and Council.
- \bullet Gene Palmer, Street Superintendent said they are preparing for any snow that might come along.
- Chief Schilz said there have been several burglaries lately and he wanted to encourage people to lock their front and back doors. Also to report anything that seems out of place. So far he said they haven't been able to identify a pattern in the burglaries.
- Jake Olsen, Golf Course Superintendent said his mechanic is going through all the mowers and servicing them. He said the wood is all pulled off of the bridge on hole nine and will be replaced.
- Courtney Lewis, Economic Development Director said she got a preview of the new website last week and it looks very user friendly and modern. She said they are working with ITD on the downtown plan and she will keep the Council posted. Courtney said they are working with the base on moving forward with the rail line as well.
- Mark Moore, Fire Chief said on Saturday they had a meeting at the fire station with the Rural Fire Commissioners. He said this Saturday they will start the Fire one courses. They are working on a Community Risk Reduction Program with the Red Cross.
- Rich Urquidi, Director of Public Works said they started the cleanup of the old landfill last week, they had taken two hundred tons of material out and still had a lot more to go. He said Code Enforcement has really been working on trash tote violations.
- Paula Szafranski, City Treasurer said they are still working with the auditors to answer any questions they might have and they are on schedule for the auditors to present in March.
- ullet Nina Patterson, City Clerk wanted to remind everyone that signed up for City Officials day that it is tomorrow and they have a van for everyone to ride together in.
