OLD BUSINESS

<u>Discussion/Decision on City Participation with the Mountain Home Air</u> Force Base water pipeline project

Public Works Director Rich Urquidi said the window to decide is closing and he wanted the Council to take into consideration the 6,000 gallons per minute is equivalent to three to four wells the city has.

It was decided the Council would get information from the County Commissioners and research this further before it is brought back to a future City Council Meeting.

NEW BUSINESS

Items Removed from Consent Agenda Section

Item E: Request to Waive Building Permit Fees for the English Congregation of Jehovah's Witnesses of Mountain Home in the amount of \$1,571.92 for their building remodel

Councilman Schroeder said there was a similar situation a year ago from the Baptist Church and the Council has never approved a waiver of Building Permit Fees for a church that he is aware of. The main reason being they are already tax exempt and receive city services free of charge. He said there are three provisions in the Idaho Constitution that prevent this.

Councilman Bundy asked if the City had a history of waiving fees in these situations.

Councilman Schroeder answered fees are routinely waived for government entities and there are a couple private entities fees that have been waived for facilities that are open to the general public. He said he felt the ordinance needed to be amended so it was clear the City cannot do that for religious entities.

Building Official, Mike McCain said in the time he has been with the City they have never waived building permit fees for church organizations.

Councilman Schroeder made a motion to deny the request to waive building permit fees for the English Congregation of Jehovah's Witnesses of Mountain Home in the amount of \$1,571.92 for their building remodel. Councilman Bryant seconded the motion.

$\underline{\text{Discussion/Decision}}$ on proposed changes at the Cemetery by the $\underline{\text{Cemetery Sexton}}$

Larry Cronin, Cemetery Sexton said he would like to have section F in the Cemetery changed so that the headstones in that section can be either Council Minutes - February $27^{\rm th}$, 2017

flat or raised. He said last year the Cemetery had 65 funerals and only three were in the flat section. He said Section D is the only section left to buy plots in a raised section.

Mayor Sykes asked how much more mowing time it would take each week if the section was converted to allow raised headstones.

Larry answered it would add about six hours of trimming.

Councilman Bundy asked if the six hours would be absorbed into the current man hours budgeted or if they would need additional funding.

Larry said it was something they could take on with the man hours the Cemetery has now and less than the man hours they would need if they needed to start using the additional five acres that are in the annex area. He said there is also the niche wall for cremations.

Larry said he would like to change the ordinance that says you can only have one full casket and two sets of urns put into one site and change it to say two caskets and two urns can be put into a plot. He said they would only need to make each grave another half foot deep to maintain the eighteen inches of soil on top.

Councilman Schipani was present at 6:23 and the meeting continued.

Nina Patterson, City Clerk said she just wanted to make it clear that the decision would have to be made when the first person went in, they couldn't change their mind later to add another casket.

Councilman Schroeder made a motion to approve the proposed changes at the Cemetery by the Cemetery Sexton. Councilman Bundy seconded the motion.

Discussion/Decision on the purchase of a Liquor License

Paula Riggs, Economic Development Director said the City currently has fifteen liquor licenses out and according to state code we are only allowed nine with a population the size of Mountain Home. She said Economic Development received a call from the owner of Cal's Bar that he is interested in selling his liquor license. Paula said she did some investigating and the City could buy the license and lease it out to a business. She said there is no set price on it at the moment but the bar owner is saying between \$100,000.00 and \$150,000.00.

Councilman Bryant said the price he is asking is very inflated. He said he thought a license would only be worth \$30,000.00 to \$40,000.00.

Mayor Sykes said he couldn't see spending more than the license was worth to buy it.

Councilman Bundy asked what the lease amount would be for a restaurant.

Mayor Sykes said it would be whatever the City decided to charge.

Councilman Schroeder said he is reluctant to entangle the City in what is essentially a private market and a private business.

Councilman Bryant said he has no problem with the idea but he thought the price was outrageous.

Councilman Schroeder said the additional concern is we can get another restaurant here. He said if the City were to facilitate the transaction the City would then be subsidizing the competition.

Jay Friedly, City Attorney said there are some issues as to whether the City should even buy a license.

Councilman Schroeder said he would like to distinguish between if it is permissible with Alcohol Beverage Control and if it is permissible for the City to do this. He said from the research he has done so far it is not something that can be done.

Councilman Bundy said he would like to know what other Cities are doing this and how it is working for them.

It was decided Councilman Bryant would do more research with Paula Riggs, Economic Development Director.

ORDINANCES

Ordinance - Updating sections 9-3-2, 9-7-8 and 9-9-2 of Land Use and Development for Carports in Setback Areas

Councilman Schroeder asked Building Official, Mike McCain if some changes could be made to the ordinance before the Council passed it.

It was decided there would be changes made to the ordinance and it would be brought back to the next Council Meeting on March 13, 2017.

FINAL COMMENTS

• Councilman Schroeder said there was a bill in the packet it would allow the County Commissioners to decide if property owners should get tax exemption. He said his only concern is there is a clause where it could be decided on trade secret. Currently the amount is set at \$3,000,000.00 and it would change to \$500,000.00.

Councilman Bundy said if they are going to claim a value it should be common knowledge what the value is.

Paula Riggs, Economic Development Director said she has known about this but not on personal property, it has always before been a \$3,000,000.00 Capitol Improvement.

Councilman Schroeder said new plant and building facilities means manufacturing facility or facilities and personal property related thereto.

Paula said she has always felt the \$3,000,000.00 was too high of a number for rural communities but \$500,000.00 could be going from one extreme to another.

 \bullet Councilman Bryant asked if we are likely to get any of the matches Buxton Company has given us.

Paula Riggs said they were just given those matches and are now in the preliminary stages of sending Mountain Home's portfolio to those matches.

• Nina Patterson, City Clerk wanted to let the Council know because of the City working to get employees on workmen's comp back to work as quickly as possible the experience modification for the City is down to .75 which has saved Mountain Home \$34,000.00 in premiums.

- Tiffany Belt, Deputy City Clerk said the City has been working on wellness in a hope to lower insurance premiums because they are set to go up substantially when the policy is renewed.
- Councilman Schipani asked Paula Riggs what happened with the new sushi restaurant.

Paula said he is still interested though has had some setbacks with his other restaurant. She said he is scheduled to make another site visit to Mountain Home.
