• Councilman Schipani asked about the cost of snow removal.

Gene Palmer, Street Superintendent said it was from the winter storms and to keep the town from flooding.

Councilman Schipani said in the future if it is going to be over \$2,500.00 there should be a Special City Council Meeting held to approve the expenditure.

• Councilman Schipani asked if item J was already in progress.

Public Works Director, Rich Urquidi said that it was.

Councilman Schipani said it was frustrating to him that a project would be underway before it was approved because there was always the chance the Council could deny it.

• Councilman Bundy said in regard to item M that he is a full time employee of the Mountain Home School District but the waiver of fees has no direct impact on him and will not benefit him in any way.

Councilman Schipani said his wife also works for the School District but like Councilman Bundy the waiver of fees will not directly impact himself or his wife.

• Councilman Schipani asked if Item K would be taken out of Wastewater.

Public Works Director, Rich Urquidi said it would come out of the Streets Stormwater budget. He said the cargo container would hold 900 to 1000 sandbags at a time.

Shelter and the owner pay the fees for the dog to be quarantined.

Councilman Schipani said he called other cities to find out how they handle quarantines and all of those cities said they handle it the way Sandy described, so he had no problem making an ordinance change as described.

Mayor Sykes said he spoke with Animal Shelter staff and the reason they don't take quarantine animals is the Animal Shelter is so small, but they did say they could try it.

Nina Patterson, City Clerk said there would have to be a public hearing before this could be changed since there would be a new fee. She asked if the animals would be quarantined at the Animal Shelter or a boarding facility because the fees would need to be based accordingly.

It was decided City Attorney, Jay Friedly would work on an Ordinance change, the fee is to be determined and a Public Hearing would be set for a future Council Meeting.

- Police Chief, Nick Schilz said the Police Department has been really busy. He said they are still working through a process of hiring. Nick said they are considering combining a couple of positions and adding an additional patrolman.
- \bullet Mark Moore, Fire Chief said his firefighters are back from the stair Council Minutes March $13^{\rm th},\ 2017$

climb and they are in the middle of the testing process for the four open positions on the Fire Department. He said the training officers are doing a great job. Mark said in April they will start training with BLM.

- Dave Sonnentag, Water Superintendent said Hiddleston Drilling is at Well #12 working on it this week.
- Gene Palmer, Street Superintendent said the department has been busy. He said they are doing traffic counts and cleaning up the streets.
- Todd Monasterio, Parks Assistant Director said they have been working at the BMX track tearing a fence down and they will be putting fertilizer in this week.
- Shirley Batchelor, Wastewater Superintendent said they are getting the land ready to farm. She said they have a lot of extra water right now they are storing.
- Courtney Lewis, from Economic Development said they are currently working on the new Buxton Company matches and prepping to meet with many of the matches at the ICSC Conference in May. She said they are still working on the Downtown plan and working with Urban Renewal on that because they are interested in partnering on the project. Courtney said they are continuing to work on the Industrial Park and they have had their first update with the planner who was contracted for the project.
- Rich Urquidi, Public Works Director said the ADA Playground Equipment for Carl Miller Park went to the next phase in the grant process, he said he and Susie Colthorp, Grant Administrator would go to Boise on March 22nd to present for the grant and hopefully make it to the next phase. He said the Senior Center grant is moving forward as well.
- Larry Cronin, Cemetery Sexton said they are still cleaning the Cemetery for spring.
- Paula Szfranski, City Treasurer said at the next Council Meeting the auditors would be here to present the final audit conclusion. She said after this bill run the worksheets will go out to Department Heads to work on their cash carryover projections and then the City will move forward with the budget process.
