### Update on Library Roof Repair

William Lamb, Librarian said he has been working with an architect firm to come up with a solution for the Library roof. He said the pitched roof is too expensive and the foam roof is also out of the question because of the damage that has already been done to the roof. William said the recommendation he was given is to replace the membrane that is up there now.

Councilman Schipani asked if we could not put a pitched roof on it since that is the plan for all the other City buildings that are getting new roofs.

Mike McCain, Building Official said the issue with that is the cost. He said it would be about \$500,000.00 to put a pitched roof on the Library because of the size of the building.

William said he would work with the Library Board and Mayor Sykes on how to fund the repairs.

He said the first step is to do a flyover and use Li Dar to see how high everything is. The total cost of the Li Dar is \$28,000.00; he said the City would be responsible for a portion of the cost.

Councilman Schipani said it would be a benefit to everyone in that area if it were rezoned.

Nina Patterson, City Clerk asked how much the City's portion would be.

Councilman Schroeder said it was unknown right now but he thought the portion the City paid was somewhat negotiable.

#### FINAL COMMENTS

- Paula Szafranski, City Treasurer said she wanted to let the Council know she is still working on the budget for the next fiscal year. She said some reductions had to be made and the Council's books would be ready Friday.
- Nick Schilz, Police Chief said it has been brought to the Department's attention about parking in Railroad Park during the Farmer's Market where the road narrows. He said he would like to work with the Street Department on this issue so they could at least block off enough room that an ambulance could fit through if needed.

Councilman Bryant said we could speak to Bev Lucia who runs the Farmers Market to see if she could help come up with a solution that would work for everyone.

• Tiffany Belt, Recreation Superintendent said the lights at the pool have been inspected and are ready to go. She wanted to know if it was possible to remove the no dogs signs in the City Parks, if we are not going to enforce the no dog rule.

Police Chief Schilz said it is something that is very hard to enforce because people claim dogs in the park are service dogs and they are not allowed to ask someone to provide proof of that. He said he would appreciate any input the Council could provide.

• Rich Urquidi, Director of Public Works said the crow's nest at Optimist Park is up. He said there is still a lot of water in the sewer lagoons but with the weather heating up he expected the levels would go down quickly.
