other polices with the changes and would like the Council to review them. She said at the next meeting she will be asking the Council to approve the current changes, unless they have any further changes to be made.

Councilman Bryant said he had a question on page five of the personnel policy. He would like to know why there is an age of forty or over with the harassment policy.

Councilman Bundy said he thought they were referring to age discrimination starting at forty.

Councilman Bryant said he had a question on page nineteen and he wanted to know if Parks and Recreation had been separated.

Nina said they took out that part of the policy because there is no Parks and Recreation Director anymore but a separate Superintendant for both Parks and Recreation.

Councilman Bryant said he wasn't sure exactly where it should go but should it specifically state that employees are not allowed to have an affair with another person's spouse.

Nina said it doesn't make specific reference to it but there is reference to employee conduct, outside of the workplace as well. She said she would check with ICRMP to see if there was wording that could be added to that effect.

Councilman Bryant said he wanted to discuss the issue of people who aren't promotable occupying positions that block other people from promoting. He said we shouldn't have to go outside to look for Department Heads when one leaves the employee beneath that Department Head should be capable of stepping into that position or they shouldn't be in that position.

Nina said the job specifications say you have to meet certain requirements or you cannot advance.

Councilman Bryant said they shouldn't be able to stay in the current position if they are not qualified to advance.

Councilman Schipani said the employees we have meet all of their qualifications to keep their jobs.

Councilman Bryant said he didn't want to see anyone held back because there are other people occupying positions they weren't qualified for.

Councilman Perez asked if you have people ready to step up to the next level blocked by people who don't want to move up would you be at risk of losing employees you have spent money to train.

Councilman Bundy said if you bump someone out of a position they are good at to put someone in there who wants to promote you have the same problem in reverse.

It was decided Nina Patterson, City Clerk would look into the questions that had been raised and redo the policy as needed.
