OLD BUSINESS

Spring Soccer Program

They are two weekends into soccer with three more to go; May 5th will be the last day. Everything is going well and the officials are doing a really good job. Item closed.

Arbor Day Celebration - April 27, 2018

The celebration will take place at 11:00 a.m. at Richard Aguirre Park. Beginning right at 11:00 the newspaper will be present to take photos as the proclamation is read. Idaho Power awarded the city \$400 to purchase a tree to plant. They also received the Idaho Arbor Day tree planting grant for \$300. Typically agencies can get this grant two years in a row and then don't receive it the third year. This is the second year so we likely won't see it in 2019. They worked with Brad Stokes and through the University of Idaho greenhouse they were able to get different types of trees and more of them to give out to the public. This year they will be giving out 100 Antelope Bitterbrush, 100 White Pine, and 100 of a third species that they couldn't remember the name of. In past years they've only been able to give out 100 Blue Spruce to the community so they really want to provide more to the public. Item Closed.

NEW BUSINESS

STEM Programs

Brad Stokes and Tiffany are currently looking for grant funding opportunities. Tiffany said they are also putting notices in the next water bill seeking instructors for coding and any type of STEM education. Carry forward.

Swimming Pool

The pool has been cleaned and is ready to be filled. They had to redo the drains to meet the Virginia Graeme Baker Pool and Spa Safety Act because they did not meet the requirements. They also changed the water turn on in the parking lot. They have approximately 32 summer hires; one will be shared with parks and there are eight attending lifeguard training. The pool will open on June 2nd and close on August 11th. Carry forward.

Optimist Multi-Use Complex

Miguel shared the layout with the committee. There will be 18 RV spots. The project will be completed in phases but they are hoping this year to get the drip system in for the trees. They were going to have a pond but they have decided to turn it into a fire pit. Next year they will put in the dump station so until then it will just be dry camping.

Miguel also presented the oval track with the rugby field on the inside of it. They are hoping to complete the rugby field this year. If the rugby field is established in time, the rugby team is hoping to bring the state tournament here next year. Item closed.

Mountain Home Pollinator Protection Policy

Brad was able to complete the policy just prior to the meeting. It is still a work in progress and is being forwarded to the city attorney for review. Brad's biggest concern is making sure that the policy doesn't say that the city can't use particular products/chemicals; just when possible an alternate may be used. The committee will review the policy and discuss it further next meeting. Carry forward.

Fred asked if anything had been decided on the process for Eagle Scout projects. Item added to the agenda for the next meeting.

Tiffany said that Spring Clean Up is scheduled for May 7th-11th with Hazardous Material Waste Day on May 10th.
