*Discussion/Decision/Recommendation-Tabled from previous meeting-Ordinance Change-repeal 9-6-8: Letters of Information/Lot Splits and Enacting New Section 9-6-8:Minor Division of Lands

Mike McCain stated, "The issue of the parcels created prior to January 20, 1994 was due to the County having problems with parcels dated prior to that date. The County will be repealing that portion of their Ordinance also. I have removed it from the Ordinance."

Commission Member Ralph Binion made a motion that the Planning and Zoning Commission recommends to the City Council that it approve and adopt the proposed repeal of the existing City Code Section 9-6-8 and the enactment of a new City Code Section 9-6-8 concerning minor divisions of lands by providing for the purpose and applicability of the new Section 9-6-8, providing for the process for the application and approval of an application for a minor division of lands, and providing for standards and required findings for the minor divisions of lands. Commission Member Mary Miracle seconded the motion.
