Item F: Approve Amended Grant Application Approval Request for Grant #2018/19-007 to allow the Grant Administrator to apply for an Idaho Department of Commerce - Community Development Block Grant for Phase II and III of the Downtown Revitalization Plan in the amount of \$500,000.00 with a City Cash Match Requirement. Councilman Brennan said they had tentatively passed to go out for the grant without the details involved but now it has come back that the cash match will be \$1,100,000.00 and he would like to know where that money is going to come from.

Director of Public Works, Rich Urquidi said there are three phases to the grant which will be done over three budget cycles, so the payments would be broken into three budget cycles.

Councilman Bundy said regardless of whether or not the City applies for the grant they will be spending the money in the downtown area, so they might as well apply to get the grant if they are already planning on spending the money.

Councilman Brennan said he wanted to be honest, he likes the idea of a downtown plan but cannot fully get behind the current concept the City has for the downtown. He said the downtown plan is supposed to carry us twenty to thirty years into the future and he doesn't see how cutting it down from three lanes to two will work that far into the future.
