There was a discussion about the agreement with Westside Sewer District. The developer said the agreement between the Sewer District and the City wasn't clear.

Brock Cherry, Community Development Director went over the proposed project Mountainbound Custom Storage and RV Park.

Councilman Brennan said he thinks it is a great product. He said in terms of access, that intersection at Highway 20 and Foothills Road is a disaster without additional businesses being added. He said he wouldn't want to proceed without a secondary ingress and egress. He said safety and flow of the road have to be priority.

Councilwoman Garvey echoed Councilman Brennan's concerns and asked if Mountainbound Custom Storage could work with Johnson Brothers Hospitality on an agreement to help with the congested roadway.

Brock said in his experience most companies need to have something built before they have the money to make changes to the roadway. He said he has to have trust in ITD and their studies.

Councilman Brennan said he doesn't want to outright deny the application but this is something that has to be worked out.

The project developer said he understood completely and they are prepared to share in the cost and do whatever needs to be done.

Paul Fitzer, City Attorney said the Council needs to specify now the things that will be required at each stage of development.

Councilwoman Garvey made a motion to approve annexation of the MountainBound Storage and RV Park with the following conditions: 99 units may be completed, after 99 units the Council is requiring the developer to provide an intersection expansion by installing a connector road east of US20 connecting North Lee Road, Hot Creek Road and Foothills Ave. to accommodate for the further expansion of his project.

Councilman Stokes said he would like to see the other conditions added as well.

Councilwoman Garvey changed her motion to include the other conditions, approving annexation to include 99 units at first buildout to include (I) under subsection 16 and (II) as conditions to this development. Councilman McCain seconded the motion.

Councilman Brennan said maybe he is seeing it wrong but with that motion the developer is responsible for the entire road, and he thinks a latecomers agreement should be discussed.

Councilwoman Garvey said the developer has already agreed to do whatever infrastructure is needed to complete the project. She said her motion stands adding however, subject to potential latecomers in the future. Councilman McCain seconded the motion.

Councilman Brennan said he felt they were jumping into this too quickly. He said the median will be coming immediately before the development and a light would be much further down the road, so businesses on both sides would be blocked one way or another.

There was a discussion about the roadway and its funding.

Councilman Brennan asked the developer if he agreed to fund the whole North South Road connecting to Hot Creek Road.

The developer said that was correct, the proposed development would pay for it at the 99 unit mark.
