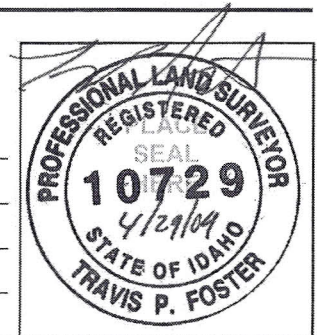

The square footage shown for the crawl space and the square inches shown for the vent openings are combined figures for the entire structure. The BFE was determined by locating the highest point along the centerline of N 18th Street East, the nearest adjacent road, which is 3146.4 feet and adding 2.0 feet for the AO (Depth 2) Flood Zone designation, for a BFE elevation of 3148.4 feet per instruction from FEMA on response letter to LOMA application dated April 7, 2009. Equipment servicing the structure are air conditioning units.
