OLD BUSINESS

Discussion/Decision on Planning and Zoning Commission Recommendation to approve the request by Cody Hunter Black for the Annexation and Zoning to C-4 of the Meadows Mobile Home Park located at 1075 Airbase Road and adjacent parcel with conditions. ACTION ITEM.

Brock Cherry, Community Development Director explained the process Mountain Home has gone through with Cody Hunter Black to address the concerns the City has with annexing the Meadows property. He said he is recommending to City Council they approve the annexation pending a signed and agreed upon annexation agreement between the City and Cody Hunter Black.

Councilman Bundy made a motion to approve the Planning and Zoning Commission Recommendation to approve the request by Cody Hunter Black for the Annexation and Zoning to C-4 of the Meadows Mobile Home Park located at 1075 Airbase Road and adjacent parcel with conditions and pending a signed annexation agreement between the City and Cody Hunter Black. There were no items removed from the Consent Agenda.

 $\underline{\text{Discussion/Feedback}}$ on the proposed changes to Imagine Mountain Home Program. ACTION ITEM.

Brock Cherry, Community Development Director said he was tasked months ago with making changes to this program so that every decision does not have to go through the City Council. It would be best if there were clear rules to the program it would be easier for the Council and the business owner. He said he would also like to see the businesses be able to access soft services, such as website development provided as well. Brock laid out the changes he would like to see implemented to the program.

Councilman Brennan said he felt Brock did a great job, but he would like to see eligibility requirements like how often a business is eligible for the program.

Councilman Stokes said since the City has already invested so much in the downtown area, he felt we could give up to \$2,000.00 for businesses that apply for the program.

The Council discussed they would still like the majority of the program aimed at fixing the exterior of downtown buildings. The consensus was a 60/40 split between physical upgrades and soft services offered through the Imagine Program.

It was decided that Brock would finalize the new requirements to the Imagine Mountain Home Program and come back to the Council with them for final approval.

Discussion/Decision on Recommendation from the Airport Advisory Committee to change Chapter 5 of the City Ordinance to have the Airport Rules and Regulations and Minimum Standard be adopted by resolution. ACTION ITEM.

Director of Public Works, Rich Urquidi said the recommendation is to clean up and minimize this ordinance. He said this is a draft for the Council to look at and will be finalized and brought back to the Council as a Resolution rather than an Ordinance.

Paul Fitzer, City Attorney said it would be similar to the International Builders Code the City has adopted, the whole thing isn't printed in our ordinances we just state that we follow those guidelines. He said since so much of the Airport Regulations are federal the City would follow their current regulations.

It was decided to move forward with the recommendation from the Airport Advisory Committee to change Chapter 5 of the City Ordinance to have the Airport Rules and Regulations and Minimum Standard be adopted by Resolution and brought back to the Council for final approval of the resolution.

<u>Discussion/Decision on Recommendation from the Airport Advisory</u> Committee to adopt the fuel flowage fees as printed. ACTION ITEM.

Director of Public Works, Rich Urquidi said the current rate for the contractor is an eight-cent flowage fee and they would like that fee to apply to everyone getting fuel from a tank at the airport. He said they are asking for a public hearing to make the change, since it is a requirement when a new fee is imposed by the City.

Councilman Stokes asked if the Airport Manager was also paying the fee.

Rich said CK Aviation is paying the flowage fee in accordance with their contract.

Councilman Bundy made a motion to approve the recommendation from the Airport Advisory Committee to adopt the fuel flowage fees as printed and approve a Public Hearing to be held on this matter on a date to be determined at the City Clerk's discretion. Councilman McCain seconded the motion.
