

ORDINANCE NO. _____

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021, APPROPRIATING THE SUM OF \$73,938,895 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF MOUNTAIN HOME FOR SAID FISCAL YEAR, AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MOUNTAIN HOME, ELMORE COUNTY, IDAHO:

SECTION 1. That the sum of \$73,938,895, and the same is appropriated to defray the necessary expenses and liabilities of the City of Mountain Home, Elmore County, Idaho, for the fiscal year beginning October 1, 2021.

SECTION 2. The objects and purposes for which such appropriation is made and the amount of each object and purpose as shown below:

SECTION 3. That a general tax levy on all taxable property within the City of Mountain Home, Idaho be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2021.

SECTION 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 5. This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Mountain Home News, a newspaper of general circulation in the City of Mountain Home and the official newspaper of said City.
