Item 6) Discussion/Decision –2026 Budget. Hear public comments if any. Final approval of the Budget. ACTION ITEM: The preliminary budget was approved last month. There were no public comments. Commissioner Bermensolo made a motion to approve the fiscal year 2026 Budget

Chairman Valley stated he asked the URA attorney to draft the reimbursement agreement for \$350,000 to Marathon. Next meeting there should be a draft to approve. There will not be a bill until the power is put in.
