FINAL COMMENTS

- William Lamb, Library Director said they have finished their 2019 goals and have started their 2020 goals. They are working with Boise State to help non traditional students have better access to higher learning.
- ullet Courtney Lewis, Economic Development Director said she has hired a new employee and she starts the $22^{\rm nd}$. The annexation agreement with the Rail Industrial Park is the $27^{\rm th}$ and she is getting ready to do to a conference the City is sponsoring for Industrial Asset Management.
- Mark Moore, Fire Chief said they are making sure they are ready for the 2020 fire season and they are doing some wildfire training. He thanked the Council for reappointing him.
- ullet Jake Olsen, Golf Superintendent said he is working on some of the tees and waiting on the weather to get a little better to work on some of his other projects.
- Shirley Batchelor, Wastewater Superintendent said they are keeping an eye on lagoon levels and they are doing routine maintenance of the sewer lines.
- Miguel Pedroza, Parks Superintendent said they are about done with their picnic tables and have started rebuilding some of the trailers and this week they have a nursery and landscape conference they will be attending.
- \bullet Dave Sonnentag, Water Superintendent said they will be running the water line down 2^{nd} to the new Hub Plaza.
- Tiffany Belt, Recreation Superintendent said they are starting to push their spring programming.
- Hank Patrick, Building Official said his new Code Enforcer started today.

- Gene Palmer, Street Superintendent said they have had the street sweepers out a little more and they have been keeping an eye on the weather, but it has been a late winter.
- Scott Conner, Police Chief said they have two officers in field training and they are doing a good job. They are working on Continuing Education Training. He thanked the Council for reappointing him in the New Year.
- ullet Rich Urquidi, Public Works Director said the Street Department has been fixing potholes on 2^{nd} Street. He said they are still working on City View Drive. Next Tuesday he will attend the Idaho Water Resources Meeting. All the Wastewater Storage Cells passed their tests and will not need to be tested for another ten years. He said the lights on the second block of 2^{nd} street have been turned up to 75% and you can tell the difference. Jerry Anderson has agreed to sell the City a piece of property they have been working with him on.
- Paula Szafranski, City Treasurer thanked the Council for letting the City Employees go down to the Park to put up everything for the Light the Forest Event, that event would not happen without their help. The Outdoor advertising sign is in the process and they are getting quotes from a couple different companies. She and Tiffany from Recreation will be attending a class to bring EBT to a City Farmer's Market one Friday a month at the HUB Plaza called Fresh Friday. The City fiber project is moving forward and they had a very successful Open House for it last week.
- Nina Patterson, City Clerk reminded everyone about City Official's Day at the Capitol. She said the ICRMP Online University has been completed by most employees and she will be getting with the Department Heads to schedule the required HR training for each department. She thanked the Mayor and Council for reappointing her for another year and all of the Department Heads for being such great people to work with and said she is looking forward to 2020 and seeing what the City could accomplish and he thanked all the employees who worked hard on setting that up every year.
- Councilman Stokes wished Fire Chief, Mark Moore a happy birthday and congratulated Councilman Bundy on winning a VFW award for teaching.
- Councilman Brennan said he appreciated all the hard work the Department Heads do. He said the park always looks great during Light the Forest and he thanked all the employees who works so hard on putting that up every year.
- Councilman Bundy said everyone who has worked with the Department Heads knows what a great job they do. He hoped the Department Heads would pass down to the employees what a great job they do.
