Councilman Brennan said he would like to compare the options of leasing a Wheel Loader to buying one outright. He asked how long a machine like this is expected to last.

Rich Urquidi, Director of Public Works said after doing research he has found they last 17 or 18 years but unlike a lot of the other equipment Public Works uses, this machine is not something the maintenance department can work on themselves, and maintenance is included when you lease the Wheel Loader. He said this is the only piece of equipment Public Works leases and does not buy outright.

Councilman Brennan said the current loader lease allows for 2000 hours of use and the current loader has just over 800 hours on it right now. He said in the proposed lease the hours have been cut to 1500, which is still nearly double what has been used on the current loader. The new loader would be \$83,000 over the next five years. If the loader is bought outright it would be \$144,000.00, which seems like the best bang for the buck since the City puts less hours on the equipment than the lease allows. Though the cost of maintenance is unknown for the moment.

Nina Patterson, City Clerk said the City could finance the balloon payment due at the end of the lease if the City wanted to keep the current machine.

Councilman Bundy asked Rich Urquidi why it is that this machine is leased when most other machines in the City are bought outright.

Rich said this machine is leased with the maintenance included, and this way they know the machine is ready at a moment's notice, in case there is a water main break or anything else the machine might be needed for in an emergency situation.

Paula Szafranski, City Treasurer said at one point the City owned all their vehicles outright, and it led to an aged fleet the City has struggled to update.

Councilman Bundy asked how much notice there would need to be to buy the current loader.

Nina said the \$96,000.00 owed on the lease would just need to be paid to the company by April.

Councilman Brennan asked if there is a ten year lease for the loader.

Paula said she didn't know what the lease options were but she would imagine the company would want the machine back while they can still get some use out of them.

Councilman Brennan made a motion to table this until the next regular City Council Meeting. Councilman Stokes seconded the motion.
