# 5) Non-Action Item: Discussion regarding non-resident user fee.

Councilman Green said he brought this forward because the duties of the Council is to make sure they are fiscally responsible. He said he has noticed with the Golf Course, Parks & Recreation and the Library the city residents are the only people paying taxes to support these programs. He said he would like to see a non-resident user fee for activities through Parks and Recreation. He said he would like to bring back to the next meeting a non-resident user fee proposal.

Councilwoman Garvey said she would like to see brought back how many actual non-resident users there are. She also said she would like to know what the proposed fee would be.

Councilman Bundy said Mountain Home is unique, the Air Force Base just opened up their facilities to the City for their recreation activities so he wanted to be careful of how this would affect that.

Councilman Brennan said he supports looking into this though he wasn't sure how the agreement with the base would be affected.
