Brock said with section 9-7-7C the current allowed maximum fence height is 6 ft. and he proposed allowing fences to be built to 7 ft. and anything above that height be brought back to the City Council for approval and it

would be contingent on the resident having stamped engineered plans with their fence permit that the Building Official would then sign off on.

Councilman Stokes made a motion to amend section 9-7-7C of the City Code as discussed to allow 7ft fences to be built with the guidelines given to residents applying for a fence permit on how best to build a fence to that height with anything over 7 feet having to come to the Council with stamped engineered plans for approval. Councilman Brennan seconded the motion.

Brock Cherry, Community Development Director said currently animated signs are prohibited in City Code but it does allow for message board signs which could also be construed per definition as an animated sign. He said staff is recommending that since popularity of animated signs has increased that the animated sign and message board sign be considered the same. He said there would be requirements keeping animated signs that are being produced are not overboard and that they be combined with permit signs.

Councilman McCain made a motion to amend City Ordinance 9-13 to allow for animated signs and change the code to state that the applicant have a permit from ITD on state roads before obtaining a city permit. Councilman Bundy seconded the motion.

Brock said in certain circumstances he proposes waiving the requirement that the entity developing a lot rebuild half of the existing roadway from

the center line. He said they would still have to make sure curb, gutter and sidewalk were up to code and it would only apply if there is an existing roadway already in place. The lots this would apply to would be less than a half-acre or less than 235 ft. of total street frontage. Brock also wanted to clarify this would only apply to bare lots of land.

Councilman Stokes made a motion to amend City Code Section 9-8-3A as discussed with additional verbiage when there is an existing street already constructed in front of bare lots of land, meeting the requirements. Councilman McCain seconded the motion.
