Mike Freeman, Communications Specialist said they have started streaming the City council meetings on YouTube but it is still linked through Facebook. The City is still very active on the Facebook platform. He said this would record everything so the information would be there in case of a public records request.

Paul Fitzer, City Attorney said he couldn't say if this was necessary to satisfy public records requests because the law hasn't caught up with the technology in this case. However, Facebook isn't something the City maintains, it is a medium outwards, whereas the City does have a responsibility to keep track of public comment made at City Council meetings, which is why the City keeps an audio record. He said he does think this is an inexpensive way to keep track of the responses on Facebook. Basically, he said it was not required but would be prudent.

Councilman Stokes asked if it would keep a record if someone went live on Facebook.

Mike said yes, it would keep track of everything on the City's Facebook page.

The Council discussed if this is the best way to have community involvement but not open the City to liability issues by having commenting during the live stream of the meeting. They all agreed commenting should be turned back on after the live stream of the meeting was over because it helped gage community reaction.
