Councilman Bundy asked if Cody Hunter Black had met all the conditions the City had put on the annexation of the Meadows Mobile Home Park.

Brock Cherry, Community Development Director said based on his review and the review of the Public Works Director Cody was willing to meet all of the conditions required for the annexation of the property.

Councilman Bundy said based on the fact that Mr. Black has met all of the current required conditions for the annexation he made a motion to approve the annexation agreement with Meadows Manufactured Park with Cody Hunter Black for the Annexation and Zoning to C-4 of the Meadows Mobile Home Park located at 1075 Airbase Road and adjacent parcel with conditions. Councilman McCain seconded the motion.

Councilman Stokes said he had concerns about the letter from DEQ and wondered if Cody Hunter Black had the letter from DEQ yet.

Brock said it is predicated in the development that before Cody expands or does anything whatsoever, he has to have that letter.

Councilman Brennan said he would like to clarify the motion. He said Councilman Bundy said in the motion the conditions have been met, but these are the conditions he will have to meet to be annexed.

Brock said for Cody to get the funding for all of the improvements he has to do for DEQ the City is allowing him to annex a portion and to begin certain work while being annexed, so that he can qualify for the funding before he can do any future development on the property.

Rich Urquidi, Public Works Director said everything in the park will have to be up to date before he connects to city services.

There was a discussion about which fees will be charged to the annexing property.

Councilman Brennan said he is in support of having a master plan but there are some things in this document that make him nervous. He said the document said up to two million dollars will be allocated to the project in the first year and the intent is to pull all of the one and a half million dollars in ARPA funding to use on the project. He said he remembers the Council talking about using part of the ARPA funding for a new well.

There was discussion about the prospect of building a well and where the money budgeted for the well would be coming from and how the broadband plan would be paid for.

Councilman Brennan made a motion to move forward with a Conceptual Broadband Plan for future development.

Councilman Stokes asked if that was the correct motion or if it would need to be motioned as approve a broadband master plan with the correction of calling it a conceptual plan.

City Attorney, Paul Fitzer said if the maker of the motion would say to accept by interlineation conceptual master plan then it could be approved.

Councilman Brennan amended his motion to state through interlineation change master plan to conceptual plan and approve it as printed to move forward in the planning stages. Councilman Stokes seconded the motion.

Brock Cherry, Community Development Director said the sequel school would like to leave their lease early, they love being partners with the City but things have changed for them. He said also with that property the City has certain things still on the property that may be theirs or ours and they would like to begin the conversation about exiting their lease.

Councilman Bundy said this was a fairly standard termination or a lease and made a motion to approve the termination of the lease with Mountain Home Academy. Councilman McCain seconded the motion.

Councilman Brennan said he would like to see added to the termination that they maintain the grounds until their lease naturally expires or the property is taken over by someone else.

Public Works Director, Rich Urquidi said it is already in the third paragraph of the termination proposal.

Councilman Brennan asked if the City would be able to enforce the offer to have the Mountain Home Academy maintain the property.

Paul Fitzer, City Attorney said he wouldn't want to go to court over it but it would be enforceable.

Councilman Brennan asked if we were to take their lease to a zero dollar lease and not have them pay us until the term is up would it make it easier to enforce.

Paul said you could do that and say the lease term is still in effect but for zero rent the City will endeavor to find a new tenant however the tenant will maintain the property during the time they hold the lease.

Councilman Bundy said he would like to amend the motion to say the tenant will go to a zero dollar lease while the City looks for a new tenant for the property and that the Mountain Home Academy maintains the grounds until a new tenant can be found or until the time the lease expires naturally.

Paul said he advises the motion be to hereby move that the council rejects the request to terminate the lease and alternatively moves that the lease be modified to allow for zero dollars rent provided that the tenant continues to maintain the property which should provide what the tenant was seeking to get out of the lease and vacate the property but not without maintaining the property until a new tenant can be found.

Councilman Bundy rescinded his motion.

City Clerk, Tiffany Belt said they actually have two leases with the City and it is the Mountain Home Academy's intent to get out of both leases.
