Approve Minutes for June 22, 2022 meeting. ACTION ITEM: Commissioner Jett made a motion to approve the minutes from the June 22, 2022 meeting. Commissioner Wright seconded. All Commissioners vote AYE. Motion passes.

Update HUB: Waiting on Idaho Power to proceed.

Update Fiber Optics: URA cannot pay to hook up the fiber optics. Possibly use grant funds to do this. The city plans to bore lines and hook up.

Discussion/Decision-Funding Railroad Park Sign: Yesco has quoted \$48,303 for the Railroad Park sign with an added \$17,500 for the concrete/pedestals. Size would be 7 feet tall with letters being 4' x 50'. City is calling this Phase 1 of the Railroad Park project. The city is also looking into adding pergola to compliment the sign. Sign would be located on Main Street at the end of American Legion Boulevard. Commissioner Bermensolo made a motion for the URA to fund the City of Mountain Home sign in Railroad Park for a total of \$65,803 per bids from Yesco and Yuarte. Commissioner Jett seconded. All vote AYE. Motion passes.

Commissioners also suggested magnesium chloride be put down in parking lot to help with dust until asphalt can be done in Phase 2 or 3.

Update Sidewalks: Rich Urquidi plans to meet with GUHO on Monday about finishing the sidewalks. Miguel Pedroza will budget for next fiscal year to finish sidewalks by the caboose.
