He said he brought this up because he was prepared to put work into finding out what options the city could bring forward to help individuals in this situation, but he wanted to know if the council was interested in pursuing this before he went any further.

Councilwoman Garvey said she would like to entertain the idea, maybe there could be a reduction based on income.

Councilman Brennan asked if we reduce costs for one group of users are we passing it onto another group.

It was decided to have Mayor Sykes do further research on the best way to move forward to look into reducing rates for those who use less of the services and bring his findings back to the next meeting.
