Councilman Brennan said it seems there are times where it may be prudent to allow food vendors to serve at the Golf Course, such as events hosted by the school district, which he has no issue with but the City should use caution as to when that's allowed.

The Council discussed the best way to change the language of the contract to protect that lessor.

Councilman Brennan said the language could state at the concessionaire's desire they may offer a plating fee; the city will allow educational institutions to bring in food as well as allow food to be brought in for the Fourth of July event at the golf course.

Councilman Brennan made a motion to have legal provide proper language as discussed in paragraph six presenting the contract to the current concessionaire and asking for a seven-day response from the time in which they are provided a copy of the contract. Councilman Harjo seconded the motion.
